



(The Deponent (Candidate) has no definite knowledge about any such convictions and he is still under bonafide impression that he was not convicted in any case. However, The Director General of Police Telangana State, Hyderabad has issued letter C.No.174/SCRB/CID/TS/Hyd/2023 Dt:21-10-2023 to the Deponent in response to his office letter Dt:11-10-2023 to inform about the pending cases against him and the D.G.P. has informed that in all (11) cases were registered against the Deponent and none of those cases are pending and gave the status of said cases. It was also informed that the Government has withdrawn (2) cases, three cases were closed in Mega Lok Adalath, Prosecution has withdrawn (2) cases, Two cases ended in Acquittal, in (1) case, the Police has filed final report stating that it is 'mistake of fact' and in one case i.e. Crime No.58/2012 of P.S. Osmania University for the offence U/s 188 I.P.C. registered against several persons including the Deponent (who was shown as A.6) which was registered during Telangana agitation when the Deponent was President Telangana Gazetted Officers, registered as C.C.No.157/2012, Conviction was recorded on 30-06-2012 and Fine was Imposed. However, the name of the Court is not furnished and the quantum of fine paid in the said case is also not furnished in the said letter. The Deponent could not recollect his memory and not in position to either admit about the said case or deny about the said case. The Maximum fine prescribed for the said section is Rs.200/- for first part and Rs.1,000/- for second part as per the information given to the Deponent. The Deponent has tried his level best to collect the details of the said case from the ecourts app and also by getting verified from the concerned Court in which the cases of said P.S. used to be during the relevant point of time i.e. IV Addl.Chief Metropolitan Magistrate, Nampally, Hyderabad, but could not get the details of the said case in ecourts app and in the said Court also. The Deponent was informed by his Counsel that the said C.C. number given by the D.G.P. pertains to the case of
